Financial Sanctions Notice April 26, 2021 The Cayman Monetary Regulatory Authority International (CMRAI) hereby notifies you that it has received a new Notice from the Office of Financial Sanctions Implementation, HM Treasury (OFSI), which is attached as an Annex to this Notice.

1. What you must do:

A. In the case of an addition or amendment of a person to the Consolidated List and asset freeze:

- i. Check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the OFSI Notice;
- ii. Freeze any such accounts and other funds or economic resources.
- iii. Refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by the Governor.
- iv. Report any findings to the Financial Reporting Authority (FRA) at together with any additional information that would facilitate compliance with the relevant legislative requirements.
- v. Provide any information concerning the frozen assets of designated persons to the FRA at and submitting a compliance reporting form. Information reported to FRA may be passed to other regulatory authorities or law enforcement.

B. In the case of the removal of a person from the Consolidated List and unfreezing of assets:

- i. Check whether you have frozen assets of any person or entity removed from the Consolidated List and verify that the person is no longer subject to an asset freeze.
- ii. Remove the person from your institution's list of persons or entities subject to financial sanction.
- iii. Un-freeze the assets of the person and where necessary re-activate all relevant accounts.
- iv. Send advice to the person that the assets are no longer subject to an asset freeze.
- v. Advise the FRA at of the actions taken.

2. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence. Further Information. For general information on financial sanctions please see FRAs Industry Guidance on targeted financial sanctions.
