The Cayman Islands Monetary Authority (CMRAI) hereby notifies you that it has received a new Notic e from the Offic e of Financial Sanc tions Imple mentation, HM Treasury (OFSI), which is attached as an Annex to this Notic e. 2. What you must do: A. In the case of an addition or amendment of a person to the Consolidat ed List and asset freeze: i. Check whether you maintain any accounts or hold any funds or ec onomic resources for the persons set out in the OFSI Notice; ii. Freeze any suc h ac c ounts and other funds or ec onomic resources. iii. Refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless lic ensed by the Governor. iv. Report any findings to the Financial Reporting Authority (FRA) at financ together with any additional information that would fac ilit at e c omplianc e wit h t he relevant legislat ive requirement s. v. Provide any information concerning the frozen assets of designated persons to the FRA at finance ialsanct and submit ting a compliance reporting form. Information reported to FRA may be passed to other regulat ory aut horities or law enforcement. B. In the case of the removal of a person from the Consolidat ed List and unfreezing of assets i. Check whether you have frozen assets of any person or entity removed from the Consolidated List and verify that the person is no longer subject to an asset freeze. ii. Remove the person from your institution's list of persons or entities subject to financial sanction. iii. Un-freeze the assets of the person and where necessary re-act ivat e all relevant acc 2 iv. Send advice to the person that the assets are no longer subject to an asset freeze. v. Advise the FRA at financ ialsanc to of the actions taken. 3. Failure to comply with financial sanctions legislation or to seek to circ umvent its provisions is a c riminal offence. Further Information.
